From 2016 to 2021, he oversaw Suez's hazardous waste and contaminated land activities in Europe, managing 1,800 employees in six countries with sales of 600 million €. At the beginning of 2022, he joins Veolia's Executive Committee, in charge of the Italy, Africa and Middle East zone, 15,000 employees in 15 countries for over 2 billion € in sales.

As Chairman of the Group since September 10, 2024, Azad Kibarian is using his experience and vision to strengthen the foundations laid by VALGO over the past two decades. He guides the Group as it continues to grow in France and internationally, with the aim of consolidating its position as a key player in environmental rehabilitation.


